

ORDINANCE NO. 19-54

Amending Section 141.22 of the Administrative Code of the Shaker Heights Codified Ordinances relative to Thornton Park Ice Rink Fees, and declaring an emergency.

WHEREAS, Section 141.22 was most recently amended in Ordinance No. 18-57, enacted on June 25, 2018; and

WHEREAS, this Council has determined to increase certain fees for the Thornton Park Ice Rink.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Shaker Heights, State of Ohio:

Section 1. Section 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights as heretofore in effect is hereby repealed.

Section 2. Section 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights is hereby enacted as amended as follows:

**141.22 THORNTON PARK ICE RINK FEES.**

(a) The fees charged for the youth hockey program at Thornton Park Ice Rink shall be:

The Director of Recreation shall determine the definition of prime and non-prime times, and the terms and conditions for hourly rental.

(d) Any employee of a business located in Shaker Heights who works at the Shaker Heights location shall be considered a "Resident" for the purpose of this Section.

Section 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare for the reason that it is necessary in the current operation of the City and further, to expedite the change to the ordinance for fall program

promotion which includes high usage at the rink, and, therefore, this ordinance shall take effect immediately upon its enactment and approval by the Mayor.
