

ORDINANCE NO. 19-93

Amending Section 141.22 of the Administrative Code of the Shaker Heights Codified Ordinances to increase hockey program fees.

WHEREAS, Section 141.22 was most recently amended in Ordinance No. 18-57, enacted on June 25, 2018; and

WHEREAS, Shaker Youth Hockey is a program operated by the City and includes a youth hockey league, spring hockey clinics, other skills clinics, and a hockey camp, and the program serves both residents and non-residents with priority for residents; and

WHEREAS, Shaker's hockey program services youth from surrounding communities including University Heights, Beachwood, Solon, Hudson, and others; and

WHEREAS, the City conducted a hockey fee study to learn more about hockey league fees in surrounding rinks in the Cleveland Suburban Hockey League (CSHL), and Shaker fees are neither the highest nor the lowest; and

WHEREAS, the most recent hockey fee increase took place in 2013 and prior to that, hockey fees were increased in 2002, 2007, and 2008, and hockey fees account for approximately 33% of rink revenue for programs and services; and

WHEREAS, the Recreation Director recommends, and this Council has determined, that the hockey fees should be increased by approximately 5%, beginning in 2020.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Shaker Heights, State of Ohio:

Section 1. Section 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights as heretofore in effect is hereby repealed.

Section 2. Section 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights is hereby enacted as amended as follows:

**141.22 THORNTON PARK ICE RINK FEES.**

(a) The fees charged for the youth hockey program at Thornton Park Ice Rink beginning January 1, 2020 shall be:

(b) The hourly rental fees at Thornton Park Ice Rink shall be:

Bulk/Special	\$168.00/hour
Early Morning - Shaker Figure Skating Club	\$60.00/hour

The Director of Recreation shall determine the definition of prime and non-prime times, and the terms and conditions for hourly rental.

(c) The General Admission and other ice fees at Thornton Park Ice Rink shall be:

(d) Any employee of a business located in Shaker Heights who works at the Shaker Heights location shall be considered a "Resident" for the purpose of this Section.

Section 3. This ordinance shall take effect from and after the earliest time allowed by law.
